Terms & Conditions

- Regular open account terms are net 15 days, and are available with approved credit. Credit applications are accepted by mail or facsimile only and are processed by mail. Please allow two weeks for processing.
- While we have no minimum order requirements, a handling charge of \$10.00 will be added to all orders under \$35.00. The handling charge is applied only once to any order and will not be added to any items backordered.
- All items are shipped FOB Kaysville, UT. On open account-UPS/FedEx orders, the freight charges are added to the invoice. All other shipments are made freight collect. All orders weighing over 100 lbs or items requiring special shipping will be special quoted for least expensive carrier, unless requested otherwise.
- Next Day Air, Second Day Air, and Third Day Air service is available via FedEx, UPS or other carrier as specified by customer.
- Any items backordered will be shipped as soon as in stock unless the backorder is cancelled by the customer.
- An invoice for freight and handling charge will be issued on any shipment refused by customer unless an error was made by ID House. Account will be placed on a "No Ship" basis until this invoice is paid.
- A \$20.00 handling charge is placed on all returned checks.
- Accounts over thirty days old will be assessed with a 1-1/2% per month or the maximum allowable service charge.
- Customer pays all collection and attorney fees if account goes into collection.
- Machines are warranted by the manufacturer, but should be returned to ID House service center when service is needed. Warranties are limited to the manufacturer's warranty unless an Equipment Performance Guarantee (EPG) was purchased and is current. For further information about EPG availability, please contact customer service.
- All returns must receive a "Return Authorization Number" within 30 days of purchase. After inspection and acceptance, return is subject to a minimum of a 20% restocking fee. Return authorization number must appear on all packages and all paperwork. All product must be in original packaging and returned freight pre-paid with copy of invoice. No returns are accepted on used equipment, supplies, non-stock, custom and special orders. No credit given on freight charges.
- ID House will not be responsible for any misprints involving incorrect pictures or specifications when supplied. All technical specifications are supplied by the manufacturer.
- An ID House Internet sale is subject to sales tax in Utah. Sales tax in other states may apply when a product is drop shipped. The buyer is responsible for remitting any additional sales or other taxes to their taxing authority.
- All signing parties **MUST** be an Officer, Manager or authorized agent of the company.
