**Pricing Policy** – All prices are subject to change. All prices in U.S. dollars only. If the price on your order form is different than our currently listed price, we will notify you when we receive your credit card number and give you the opportunity to cancel the order prior to shipping.

**Payment** – All orders will be paid by check pre-pay, Visa, MasterCard, American Express, Discover, or Wire Transfer, or Money Order. Orders can be on account pending credit approval. Accounts can be setup by submitting, by fax, an Application for Credit form. Approval of credit could take up to two weeks, and only applies to companies in the United States.

**Handling Charge** – A handling charge of \$10.00 will be added to all orders under \$35.00.

**Shipping Charges** – Appropriate shipping charges will be added to each order. All orders over 150 pounds in weight will be special quoted for the least expensive ground carrier unless requested otherwise.

**Free Freight** – When free freight is offered it will be for FedEx Ground shipping only within the Continental United States.

**Delivery Time** – Most orders are filled and shipped within 48 hours of receipt of payment. Check pre-payment orders without established account will ship upon check clearance. We use FedEx as our primary delivery service, however other carriers (i.e., UPS, many common carriers, etc.) may be requested.

**Service Charges** – A \$20.00 handling charge will be placed on all returned checks. Interest of 18% APR will be added to all past due accounts. If collection is made by suit or otherwise, the purchaser agrees to pay collection cost, including all attorney fees.

**Tax** – Appropriate sales tax will be added to all Utah customers. Other areas may be subject to tax if shipped from a warehouse within the same state.

**Returns** – Customers have thirty (30) days to return a damaged or non-working item. Authorized returns will be accepted at the discretion of ID House. All returns must receive a "Return Merchandise Authorization" number and are valid for 7 days and **MUST** be issued by Customer Service. Product must be in the original packaging, include a copy of the invoice, and be shipped freight pre-paid to ID House. Boxes without an RMA will not be accepted. After inspection and acceptance, credit returns will be subject to a minimum \$25.00 restocking fee or 20% of the product(s) cost, whichever is greater.

Opened or partially used merchandise will not be accepted for return credit. No credit will be issued on freight, handling charges or special fees. No returns on non-stock, custom or special orders.

Products that do not comply with the above policies will be returned to the customer, freight collect, or held for a customer issued call tag. ID House will not be responsible for unclaimed product left over 45 days. If you have any questions please call customer service at 801-927-3026.
